#### Pay equity


### Principle 14

MBIE will be providing you with a memo which outlines how the (Reconvened) Joint Working Group (RJWG) leads have agreed that Principle 14 will be expressed in the Equal Pay Amendment Bill. The Ministry for Women has been consulted on this memo. MBIE's interpretation was that while a pay equity settlement cannot reduce any existing term or condition of employment, parties can negotiate and agree to an overall package of a pay rate and terms and conditions that establish equal pay. When negotiating a pay equity settlement, more generous terms and conditions can be offset against the pay rate, and the overall package should reflect the value of the work performed. The legislation will be drafted to reflect the RJWG consensus.

#### Back pay

The Treasury has drafted advice to the Minister of Finance, shared with the Ministry for Women, MBIE, and SSC, recommending updated analysis on the economic and fiscal implications of back pay for pay equity claims. Treasury confirms it is 'constrained by significant uncertainty'. However, its paper seeks a direction from the Minister of Finance to continue evaluating more informed consideration of back pay options and the broader pay equity regime to support Cabinet decisions. We will update you on this advice as we are consulted on it.

#### Eaunching the GPG Strategy

#### Mana Wāhine Inquiry

The Waitangi Tribunal issued a direction on 9 July 2018 setting a deadline of 31 August 2018 for final statements of claim for the Mana Wahine kaupapa inquiry, and 28 September 2018 for the Crown's response. The Tribunal will appoint a presiding officer and panel at that point, and issue further directions on next steps for the inquiry.

We will continue working with Crown Law and other relevant departments to firm up options for approaching the inquiry, for discussion with you or the acting Minister before the Crown's response is filed in September. At this stage we consider the best time for a paper seeking Cabinet's agreement to the Crown's strategy for the inquiry is likely during the subsequent stage, once the Tribunal has agreed on the priority issues for and sequencing of the inquiry.
