Workshops on developing Agency Action Plans

Agency GPG Action Plans are due in February 2019. To assist agencies, the Taskforce, together with the PSA, will host a two-part workshop series on developing agency plans. Participants will be invited from all public service departments plus PSA organisers and delegates. Stephanie Nichols from the Taskforce will be the Ministry's representative and will be involved in running these workshops.

Workshop 1, on Monday 5 November, will be an introduction to the GPG, covering the GPG and pay equity context, causes of the gap, and presenting agency case studies.

Workshop 2, mid-November (dates to be finalised), will focus on developing a robust plan and on measuring gender pay gaps within agencies, using the guidance that is being finalised with StatsNZ. This workshop will also provide an opportunity for agencies and union representatives to discuss how they will work together to develop their agency's plan.

This week, a group of agencies that have closed gender pay gaps within the same roles are discussing draft guidelines on closing gender pay gaps in starting salaries. The Ministry for Women is included in this group. Further discussions on approach and feasibility are scheduled with the general managers in human resources next week.

Valuing all women and girls' contribution

Māori and Pacific Trades Training Hui/Fono

The Ministry attended the Māori and Pacific Trades Training (MPTT) hui/fono, hosted by the Tertiary Education Commission (TEC) last week. The MPTT consortiums raised concerns about heavy contractual compliance, inconsistent messaging on tertiary sector changes, and TEC's delayed information sharing. TEC stated it is keen to have closer working relationships with consortium members to support outcomes for Māori and Pacific learners and linking them into the workforce. The Ministry will keep in touch with TEC and advise if there are any further developments.

Suffrage 125

As part of the evaluation of Suffrage 125 outcomes, we have arranged for two questions to be added to the Omnibus Survey, led by Colmar Brunton. This is a regular online survey of 1,000 New Zealanders, based on a representative sample.

The survey questions will enable us to report on awareness of Suffrage 125, attendance at events, and any increase in the awareness of the issues affecting New Zealand women and girls. The survey will take place in late October and the results will be included in your briefing on the evaluation of the Suffrage 125 programme (7 November 2018). We will also use these results in our wider communication and report back of the programme with external stakeholders.

Distribution of the grants from the Suffrage 125 Community Fund has completed with only one organisation unable to accept their grant. The applicant was Southland Museum & Art Gallery and the approved amount was \$8,000. We approached them to discuss possible amendments to their application and they confirmed that, due to changes in their organisation, they are no longer able to take part in the proposed project.

The Ministry intended to absorb the full costs of the administration of this fund (approximately \$30,000). Following the withdrawal of this application, the Ministry has decided not to reallocate the funding and instead use this amount to offset some of the costs to administer this fund.

The Crossroads: Trans-Tasman Online Safety Conference 2018

Last week, a Ministry official chaired and spoke on a panel addressing women's online experience of digital harm. Other panel members were from Amnesty International, Shakti, Women's Legal Services New South Wales, and Shine The conference was co-hosted by Netsafe and the Australian Office of the E-Safety Commissioner. Keynete speakers included representatives from Facebook and Google. Discussions with DIA indicated it is actively considering how online safety can be addressed as part of its work on digital safety.
